Cancelling the transfer	· Transfer can be cancelled on the day of application, without additional fees, on the basis of cancellation application and passport details, submitted by the sender on the same day when the transfer was affected; both the transferred amount and the commission are subject to return.  · Only unpaid transfers can be cancelled
Callback	<ul> <li>Calling back of the full amount is affected on the basis of calling back request submitted by the customer in written form within one banking day or later</li> <li>Return of the fee is affected by the system depending on the reason</li> <li>Only unpaid transfers can be returned.</li> </ul>
Expiration date of the transfer	1 year
